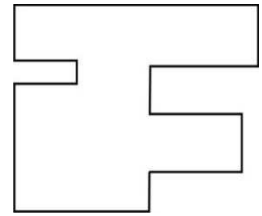

Subject: Information pursuant to art. 13 and 14 of European Regulation 2016/679 on the protection of natural persons with regard to the processing of personal data

1. Data Controller

The owner of the processing of personal data is I FANTON S.R.L., P.IVA 03194000240, with registered office in Via Treviso, 29/c- 36010- Monticello Conte Otto (VI).

The contact details of the Data Controller are reported in point 11.

2. Object and Purpose of the processing

The processing to which the personal data, directly provided or collected through third parties (commercial agents), will be subjected is aimed at pursuing the activities expressed by statute and functional to the performance of a contractual/pre-contractual relationship, including any instrumental or complementary activities, as well as specific legal obligations.

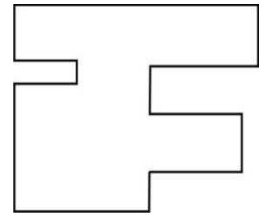
If concrete and objective situations arise for which the data of the data subject belonging to the special categories of personal data must be processed, the processing takes place only where this is necessary for the fulfilment of contractual obligations and provided that the conditions of lawfulness of processing provided for by Art. 9 GDPR and that the data subject has given his or her explicit consent to the processing of such personal data.

The processing serves to provide:

- ∅ the purposes related to an obligation provided for by law, by a regulation or by EU legislation, as well as by provisions of authorities entitled to do so and of supervisory and control bodies;
- ∅ the purposes related to and instrumental to the management of relations with customers/suppliers, concerning, by way of example, the proposal of a quote, the stipulation of the contract, the transmission of information, invoicing and the collection of payments;
- ∅ to carry out marketing activities through the sending of information material, subject to the consent of the data subject;
- ∅ the consideration of applications for possible recruitment;
- ∅ to defend a right also by the Data Controller or a third party in court, as well as in administrative proceedings or in arbitration and conciliation procedures in the cases provided for by law, EU legislation, regulations or the collective agreement applied in the company.

The legitimate interests pursued by the Data Controller related to the personal data processed of customers and suppliers are exclusively reflected in the lawful and objective need to be able to proceed with the execution of a sales/purchase contract (with the customer/supplier) to which the data subject is a party or the execution of pre-contractual measures adopted at the request of the same.

For the data collected by the form on the site, it is declared that the data processing will be carried out for:

- ∅ to satisfy requests submitted through data collection forms;
- ∅ send technical, administrative, commercial or advertising information material
- ∅ to carry out obligations under laws or regulations;
- ∅ the protection of AZIENDA's rights in court;

3. Processing methods

The processing will include all the operations or set of operations provided for in art. 4, point 2) of EU Reg. 2016/679 necessary for the processing in question, it being understood that the data provided by you are not expected to be disseminated.

Within the scope of the purposes indicated above, the processing may take place both by computer systems and in paper form and will be managed by authorized personnel of our Company and, when necessary, by external data processors specifically appointed.

The storage of data in both electronic and paper mode will last for the period of time required by the pursuit of the purposes and by the applicable laws.

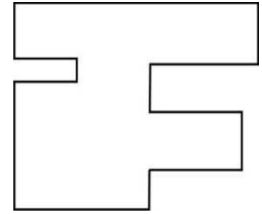
4. Mandatory provision of personal data

The provision of personal data relating to the processing described in point 2, with the exception of what concerns marketing purposes, is necessary as it is connected to the obligations provided for by applicable laws or regulations as well as by provisions issued by the competent supervisory and control authorities/bodies or to fulfil the contract in place or in the process of being established between the parties or to fulfil requests from the data subject.

5. Consequences of not consenting to the processing of personal data

Any failure to consent to the processing will not allow the aforementioned activities to be carried out, with the consequent impossibility of following up on the contract or the requests of the data subject.

In any case, even if consent is given, at any time there is the right to interrupt the processing by requesting the cancellation of the data sent to the e-mail address indicated in point 11 below, without prejudice to the lawfulness of the processing that took place before the revocation and the legitimate interest of the Data Controller.

Such a request would also imply the impossibility of carrying out the activities referred to in point 2 above.

6. Communication of personal data

Personal data relating to the processing in question may be communicated to third parties belonging to the following categories:

- ∅ Our Agents/Sales
- ∅ Credit institutions
- ∅ Debt collection companies
- ∅ Credit insurance companies
- ∅ Business Information Company
- ∅ Professionals and consultants
- ∅ companies operating in the transport sector.

With reference to the data communicated to them, the subjects belonging to the above categories may operate as external data processors in accordance with the procedures provided for by EU Regulation 2016/679.

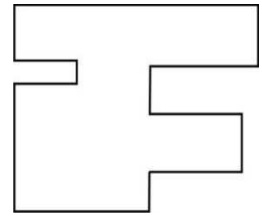
7. Data retention

The data will be stored considering the following criteria:

- ∅ at least for the period required by the regulations in force
- ∅ for the protection of the rights of the data subject, who may require verification of compliance by the company
- ∅ for the protection of the rights and legitimate interest of the Data Controller.

- Objection to the processing of personal data;
- With reference to personal data processed by automated means, the right to data portability;
- The right to lodge a complaint with a supervisory authority
